COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Criminal Sexual Conduct-1st Degree-Penetration or Contact with Person Under 13

Minnesota Statute: 609.342.1

Maximum Sentence: Thirty (30) years and/or \$40,000

Offense Level: Felony

Offense Date (on or about): 01/01/2005 to 12/31/2006

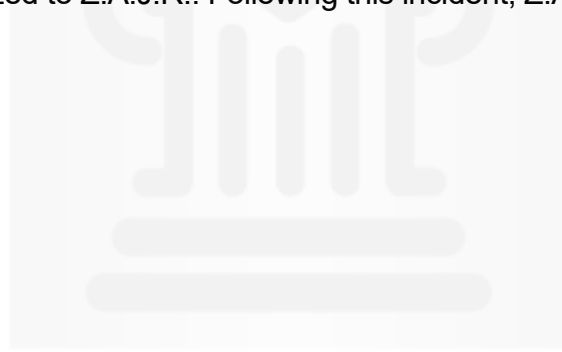
Charge Description: The Defendant, WILLIAM ARTHUR KALLIGHER, DOB: 19600717, did engage in sexual contact with a person under 13, as defined in section 609.341, subdivision 11, paragraph c, to wit: ZAJR, born in 1996.

STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

In the summer of 2021, an investigation was launched into numerous sexual assault allegations by WILLIAM ARTHUR KALLIGHER, D.O.B. 07/17/1960, hereinafter referred to as the Defendant. One of the victims who came forward was Z.A.J.R.

Z.A.J.R., Y.O.B. 1996, has a familial relationship to the Defendant. Z.A.J.R. reported that when he was nine or ten years old, which would be between 2005 and 2006, he was helping the Defendant remodel a house in the West Duluth neighborhood in Duluth, St. Louis County, Minnesota. When they were finished working on the house one day, they went into the sauna of that house. The Defendant exposed his penis to Z.A.J.R. and put his penis in Z.A.J.R.'s mouth. Z.A.J.R. was able to get the Defendant's penis out of his mouth. The next day, the Defendant apologized to Z.A.J.R.. Following this incident, Z.A.J.R. started to act out and run away from home.

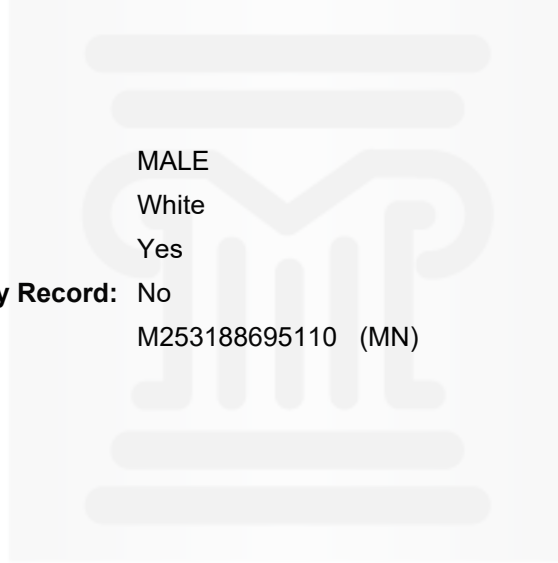
