STATEMENT OF PROBABLE CAUSE

The Complainant states that the following facts establish probable cause:

In the summer of 2021, an investigation was launched into numerous sexual assault allegations by WILLIAM ARTHUR KALLIGHER, D.O.B. 07/17/1960, hereinafter referred to as the Defendant. One of the victims that came forward was So.G.K..

So.G.K., Y.O.B. 2005, has a familial relationship to the Defendant. She lived with the Defendant at 301 North Central Avenue in Duluth, St. Louis County, Minnesota. She detailed numerous incidents of the Defendant taking her clothes off and touching her body in an "explorational" way, which she said was slow and gentle. She described three specific incidents approximately two to three years prior to her report, which would be between 2018 and 2019. She remembered the Defendant being high on marijuana during the incidents. After one of the interactions, the Defendant did apologize to So.G.K. while she was playing a game.

So.G.K. said there was a time when she was alone with the Defendant in his bedroom. He took her clothes off and put his mouth on her vagina. She tried to block most of that incident from her memory and said she did not like it.

So.G.K. said there was another incident, close in time, where they were alone in the Defendant's bedroom. He lifted her shirt up exposing her bare chest. The Defendant then put his mouth on the "center boob area." She said that if felt weird.

So.G.K. said that between the ages of 13-14 years old, which would be between 2018 and 2019, the Defendant tried four to five times to get her to put her mouth on his penis. He would be naked in the bed and would direct her mouth to his penis by grabbing the back of her neck. She described the Defendant's penis as "notified" during these interactions. So.G.K. would find an excuse to leave the bedroom before his penis would go into her mouth by claiming she would have to go to the bathroom. After one of those times, the Defendant saw her the next day and asked why she never came back to the bedroom.
